Board Meeting

07 March 2002

President Nina Chaffin called the meeting to order and read A Collect for Clubwomen as the devotional. Members present: Jean Clements, Johnnye Hutchins, Gwyn Chesnut, Joy Gould, Joan Borders, Callie Mohn, Eleanor Hoomes, Martha Thurman, Edith Maxwell, Karen Hartley, and Martha Ann Saunders.

OFFICER'S REPORTS

President Nina Chaffin – read a letter from Kathy Lowry, director of the Parenting Program at Carroll Tech, expressing thanks for our help recently in obtaining baby items for a young mother. A discussion was had as to adopting the Parenting Program as a CIP project. Once the CIP committee is formed more information will be forthcoming regarding this project. Distributed information pertaining to the state convention to be held in Duluth April 12-14. Nina, Martha Ann, Karen, Tish, and Johnnye plan to attend.

1st Vice President Martha Ann Saunders – presented membership applications of Elaine Castleberry, sponsored by Johnnye Hutchins, and Lora Tate, sponsored by Sharon Hearnburg, for approval; applications were approved unanimously. Martha Ann reported that Betty Collins Jones has agreed to accept inactive status in lieu of resigning because of the lack of handicap facilities at SHCC. Nina discussed our concern about the lack of these facilities with a representative of SHCC and reported they were very cooperative and willing to work with us in any way possible to correct this problem.

Recording Secretary – in Sharon Hearnburg's absence, Jean Clements reported that the February board meeting minutes were attached to the newsletter.

Corresponding Secretary Joy Gould – read a letter of resignation from Betty Walker Gray. Betty's resignation is necessitated by her impending move from Carrollton. Johnnye suggested Betty be contacted and urged to transfer her membership to the Monroe CWC. Joy expressed concern over the poor attendance at the February general meeting. 28 members attended this meeting.

Treasurer Callie Mohn – beginning balance, \$5,700.29; balance forward, \$5,510.05. Callie distributed forms to be submitted for reimbursement of expenditures. Karen asked that members be reminded of the requirement of committee chair approval before expenditures are reimbursable.

Unfinished Business – Martha Ann gave an updated report on liability insurance for CCWC. A policy with RKI, the GFWC liability insurance plan, which would cover our needs adequately, cost \$325.00 annually. This is in line with other plans under review. More information will be obtained prior to adopting a policy.

DEPARTMENT REPORTS

Arts – Nina reported Anna Fazio and Johnnye Hutchins have agreed to co-chair this department.

Conservation – Eleanor Hoomes – department meeting held March 4th; new member Lora Tate was welcomed; plans are moving forward for developing a butterfly garden at the Perry house; conservation will work with the Tour of Hidden Gardens again this year; everyone was urged to join Friends of McIntosh and to participate in the McIntosh Walk and Talk programs; Lisa Hollingsworth Walker will speak at the April general meeting.

Education – Martha Thurman – distributed schedule and list of panelists for CLEW; article will be placed in newspaper.

Home Life – no chair has been named for this department to date. Joy Gould reported March of Dimes Saturn raffle tickets are still available. Martha Ann reported that Betty Collins Jones has agreed to do a program on New Hope Boy's Home at the May meeting, Home Life's program month. Martha Ann will obtain the booklet, "Women's Health Guide" for Home Life. A suggestion was made that we explore participating in the upcoming Breast Cancer Walk.

Public Affairs – Edith Maxwell – Martha Ann reported coupons valued in excess of \$1,300.00 mailed to COMFELEACT.

COMMITTEE REPORTS

Tallulah Falls – Joan Borders – Dr. Gary Coker has resigned as president of Tallulah Falls School. Dr. Kent Anglin is now president and will speak at the March general meeting. A fall trip is planned to the school.

Community Improvement Projects – Karen Hartley – BTIO dolls were placed at Central Middle School; Karen presented program at Carrollton Lions Club; recommendations to be submitted to the Carroll Tomorrow Committee addressing concerns of high teen-age pregnancy rate in Carroll county.

Hospitality – Nina will serve as interim chair.

Book Club – Johnnye Hutchins – hostess for March meeting will be Sharon Hearnburg, date and time will be announced later.

Legislative – Martha Ann Saunders – several pending conferences: Georgia Women of Achievement and Southern Women in Public Service, details on these will be in newsletter. **Fundraiser – Jean Clements** – 171 pancake breakfast tickets were sold and a \$35.00 donation was given. CCWC will receive \$445.00 for our participation in this project.

Helen Faye Lewis has agreed to serve as historian and Johnnye Hutchins will chair scrapbook and publicity.
