## ***From Our Treasurer***

It has been a pleasure to serve as your treasurer this year. I truly appreciate the support and cooperation with which you have adjusted to the changes in our collections. It really has saved me a great deal of time and effort and has made tracking club income and expenses much easier and more accurate. With the club books on a computer system, we are able to quickly get all kinds of summary information back. I thought you would like to know a little more about how we are doing financially. I know there are questions from time to time and when you are not involved in the day to day management, it's easy to forget how it all works! Below is a simplified summary of some key issues and some notes that may be helpful. If you have any questions, please don't hesitate to ask me and I will be glad to answer them. Karen

### Things to Know about our 2005 Dues Collections:

1. 23 members (almost half) paid in full for the year giving us nice cash flow for the club.
2. Currently 11 members are inactive. We began the year with 7 inactive members. They only pay Dues (\$40).
3. Our contract with Sunset Hills Country Club requires that we pay for a minimum of 35 lunches @ **\$9.90** each with gratuity.
4. We **only pay** Sunset Hills Country Club for the exact numbers of members present if more than 35.
5. We have averaged 38 members in attendance this year. (low 30, high 47)
6. We have paid for guests' lunches at no additional expense to members. We have average 2 guests per meeting in addition to the speaker. This is a key to membership growth.
7. Dues to GFWC & GaFWC, including Tallulah Falls School and all assessments, was \$1663.25 (**\$29.18/member**) from our \$40 collected.
8. GFWC Dues will increase another \$1 each year until 2008.
9. CCWC budgets ALL administrative expenses from club dues. \$40.00 - \$29.18 (in 2005) per member. This means \$10.82 per member.
10. CCWC 2005 budget allocated \$1157 to administrative expenses. To date, we have spent \$844.53. That is **\$20 per member**. (We are in the hole and working on cash flow!)
11. ALL money raised in fund raisers has been distributed to the departments and committees to spend charitably.
12. In 2004, we raised \$4391 in our fund raisers. In 2005, we have raised \$4855.
13. We have been able to reduce the requests for money at meetings...we use to "nickel and dime" people every meeting. Tallulah is the only thing every month. It has been nice not to have so many requests. This also figures into what people were spending.

**2<sup>nd</sup> Vice President, Martha Thurman:** Encouraged members to bring filled out activity sheets to the November meeting.

**Minutes--Recording Secretary: Roberta Brown absent.** Two sets of minutes will be up for approval at the next meeting.

**Correspondence and Newsletter: Lora Tate absent.**

- The Ferst Foundation has had approximately \$37,000 donated this year and 1,264 books sent to children this month. They have a \$25,000 challenge grant from October 15 to February 15, 2006.
- Idys Overton and Martha Ann Saunders went to the annual EMC meeting to familiarize members with the Ferst Foundation.
- The Neva Lomason Library has received a grant to purchase children's books to complement the books mailed by the Ferst Foundation.
- Penny is now a new board member on Literacy is for Today and Tomorrow (LIFT).
